Application for Exterior Addition of Modification (ARC)

Planning Home Improvements?

ALL Exterior work on a house or in the yard must be approved PRIOR to the work commencing. You can obtain an ARC form on either website or by calling Monarch.

Any work that affects the appearance of your home or yard requires an ARC form. This includes but is not limited to: roof replacements, driveway paving, landscape renovations, fence installations, and more. There is an approved paint pallet for Lake Valencia. You MUST choose your paint colors from the approved pallet and submit an ARC application form. Even if you have selected a color from the pallet, you must submit a form. Contact Monarch with questions or for more information.

Community Compliance Inspections

The Spring 2021 Inspection will soon be conducted. The Board and Management encourages all homeowners to conduct a tour of their own property to identify and correct any violations in advance of the community wide inspection that will occur in late April. The list on the first page is a good heads-up of the majority of violations that we'll be looking for.

If you receive a violation letter, you are not being singled out. The HOA compliance inspections are not meant to be hurtful or authoritative, but rather to protect the communities' property values for all owners.



Annual Assessment Reminder

The 2021 Annual Assessment of \$175 was due on January 1, 2021. You have until April 16, 2021 to get payment remitted before being sent to the Association's attorney for collections.

TO AVOID COLLECTIONS: you can make a one-time payment online. Visit www.HOABankServices.com. Look for the "Online Payments for Homeowners" tab on the left. Then click the red "Make Payment" box. From there, select "Make a one-time payment as a guest" and enter for your information for payment. Call Monarch if you do not know your account number (727-204-4766).
